

## Privacy Notice (How we use Member/Trustee Information)

### The categories of Member/Trustee information that we process include:

- personal identifiers, contacts and characteristics (such as name, date of birth, telephone number, email address and postal address)
- governance details for Trustees (such as role, start and end dates and DBS clearance information)

### Why we collect and use Member/Trustee information

The personal data collected is essential, in order for the Trust to fulfil its official functions and meet legal requirements.

We collect and use Member/Trustee information, for the following purposes:

- a) to meet the statutory duties placed upon us
- b) to facilitate communication

Under the General Data Protection Regulation (GDPR), the legal basis we rely on for processing personal information for general purposes are:

- for the purpose **a)** named above in accordance with the legal basis of **Legal Obligation**

All academy trusts, under the [Academies Financial Handbook](#) have a legal duty to provide the governance information as detailed above.

### Collecting Member/Trustee information

We collect personal information via application forms, CVs, DBS clearance documentation and email requests.

Member/Trustee data is essential for the Trust's operational use. Whilst the majority of personal information you provide to us is mandatory, some of it may be requested on a voluntary basis. In order to comply with GDPR, we will inform you at the point of collection, whether you are required to provide certain information to us or if you have a choice in this.

### Storing Member/Trustee information

We share this information with:

- the Department for Education (DfE) for statutory purposes
- Members
- Trustees
- selected employees of the Trust
- the public through the DfE's 'Get Information About Schools' website and the Trust's website

## Why we share Member/Trustee information

We do not share information about our Members/Trustees with anyone without consent unless the law and our policies allow us to do so.

### Department for Education

The Department for Education (DfE) collects personal data from educational settings and local authorities. We are required to share information about our Members/Trustees with the Department for Education (DfE), under the requirements set out in the [Academies Financial Handbook](#)

All data is entered manually on the GIAS system and held by DfE under a combination of software and hardware controls which meet the current [government security policy framework](#).

## Requesting access to your personal data

You also have the right to:

- to ask us for access to information about you that we hold
- to have your personal data rectified, if it is inaccurate or incomplete
- to request the deletion or removal of personal data where there is no compelling reason for its continued processing
- to restrict our processing of your personal data (i.e. permitting its storage but no further processing)
- to object to direct marketing (including profiling) and processing for the purposes of scientific/historical research and statistics
- not to be subject to decisions based purely on automated processing where it produces a legal or similarly significant effect on you

## How Government uses your data

The Member/Trustee data that we lawfully share with the DfE via GIAS:

- will increase the transparency of governance arrangements
- will enable schools and the department to identify more quickly and accurately individuals who are involved in governance and who govern in more than one context
- allows the department to be able to uniquely identify an individual and in a small number of cases conduct checks to confirm their suitability for this important and influential role

**Note:** Some of these personal data items are not publically available and are encrypted within the GIAS system. Access is restricted to a small number of DfE staff who need to see it in order to fulfil their official duties. The information is for internal purposes only and not shared beyond the department, unless the law allows it.

## How to find out what personal information DfE hold about you

Under the terms of the Data Protection Act 2018, you're entitled to ask the Department:

- if they are processing your personal data
- for a description of the data they hold about you
- the reasons they're holding it and any recipient it may be disclosed to
- for a copy of your personal data and any details of its source
